

**ORDINANCE NO. 2019-003**

AN ORDINANCE OF THE BOARD OF DIRECTORS OF WYLIE NORTHEAST SPECIAL UTILITY DISTRICT, COLLIN COUNTY, TEXAS, DECLARING ONE (1) UNOPPOSED CANDIDATE FOR THE OFFICE OF DIRECTOR IN THE GENERAL ELECTION ORDERED TO BE HELD ON TUESDAY, NOVEMBER 5, 2019, TO BE ELECTED TO SAID OFFICE EFFECTIVE AS OF TUESDAY, NOVEMBER 5, 2019; ADOPTING AN ORDER CANCELING THE GENERAL ELECTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on August 13, 2019 the Board of Directors of Wylie Northeast Special Utility District (the "District") passed Ordinance No. 2019-001 ordering a General Election to be held on Tuesday, November 5, 2019, for the purpose of electing one (1) Director to the Board of Directors of the District; and

WHEREAS, the filing deadlines for placement on the ballot and list of write-in candidates for the General Election have expired and, pursuant to Texas Election Code §2.052(a), the authority responsible for having the official ballot prepared has certified in writing to the Board of Directors that candidate Jimmy C. Beach is unopposed for election to the office of Director of the District; and

WHEREAS, the Board Secretary has delivered the Certification of Unopposed Candidates to the Board and the Board has accepted the certification in accordance with Texas Election Code §2.052(b); and

WHEREAS, Texas Election Code §2.053(a) authorizes the Board to declare unopposed candidates elected to office and, pursuant to Texas Election Code §2.053(b), the General Election will not be held.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF WYLIE NORTHEAST SPECIAL UTILITY DISTRICT THAT:

SECTION 1. The above findings and recitals are incorporated into the body of this Ordinance for all purposes as if fully set forth herein.


SECTION 2. Candidate Jimmy C. Beach has been certified as unopposed and the Board of Directors hereby declares him elected to the office of Director and certificates of election shall be issued to the candidate-elect in the same manner and at the same time as provided for a candidate elected in the General Election. The candidate-elect will be administered the Oath of Office upon commencement of the first regular or special meeting of the Board of Directors held after November 5, 2019, and he will thereafter exercise the duties of said office.

SECTION 3. The General Election scheduled to be held on Tuesday, November 5, 2019, will not be held and is hereby canceled.

SECTION 4. The attached Order of Cancellation is approved and a copy of the attached Order shall be posted on election day at each polling place that would have been used for the General Election.

SECTION 5. This Ordinance shall take effect immediately upon and from its adoption by the Board of Directors.


